

Q: Will there be a 2019 fall test administration?

A: Yes, students enrolled in the **second semester** of the aligned English, Algebra, and Geometry courses during the fall will take an EOC final exam. See the table below for the aligned courses determined by the Curriculum and Professional Development Division.

Q: What courses will use the EOC exams as finals?

Please note this list of EOC-aligned courses is evaluated each school year.

Q: What percentage weight will EOC final exams have on the semester grade?

A: In the 2019-2020 school year, courses aligned to an EOC assessment must have the semester exam weight set at 15 percent of the semester grade. In 2020-2021 and beyond, the percentage requirement will be 20 percent of course grade. This weighting has been pre-set in the Infinite Campus grade book.

Q: Is there a minimal score associated with passing an EOC?

A: Not at this time, per the State Board of Education.

Q: Who will score the EOC final exams?

A: Paper/pencil EOC final exams are locally administered and scored by schools. The writing ELA final will be administered online and scored by the vendor. Schools are responsible for compiling scores for EOCs and providing scores to students and parents.

Q: How do I order materials?

A: Schools will order materials through the Data Recognition Corporation's (DRC) Online Enrollment System in eDIRECT. The window for entering projected total counts for all 2019-2020 semesters is August 19-23, 2019. For additional information: http://bit.ly/1920EOC_EW

Q: Are the EOCs a graduation requirement to earn a standard diploma?

A: No, AB7 has removed the EOCs as a graduation requirement. The EOCs are a course-require final exam.

Q: Do I test students who are enrolled in credit retrieval/APEX courses?

A: No.

Q: Do students enrolled in summer school take the EOC final exam?

A: No.
